## Re: Your request made under the Freedom of Information Act 2000

We are emailing to request information under the Freedom Of Information Act (2000). We are carrying out research into weight management for people affected by Severe Mental Illness.

We are asking for information about the Tier 3 and Tier 4 Weight Management Services you provide.

For the Tier 3 service, please could we see:

 A full copy of referral criteria for this service, including inclusion and exclusion criteria

For Doncaster: Referrals into the Service should only be accepted from other health care professionals such as General Practitioners.

Service Users must meet the following referral criteria;

- · Be 18 years or over
- · Have a BMI >35kg/m2 with T2DM or obesity related co morbidities (significant disease) which may be amenable to treatment if obesity is modified by surgery. Significant disease could include, established cardiovascular disease, Type 2 diabetes, sleep apnoea, hypertension medicated, history of transient ischaemic attacks or stroke, dyslipidaemia, medicated for acid reflux, IGT, osteoarthritis, PCOS
- · BMI >40kg/m2 without co morbidities
- · Have expressed an interest in accessing bariatric surgery
- · Service Users understand the requirements and commitment needed to participate in Tier 3
- · Service Users must be registered with Doncaster GP or, if registered with a GP elsewhere, be resident in Doncaster.

Exclusion criteria

- · Service Users must not have a known eating disorder
- · Service Users must not be pregnant
- · Have a BMI >35kg/m2 and Have a BMI >40kg/m2 with no significant disease

## For Bassetlaw:

referrals into the Service should only be accepted from other health care professionals such as General Practitioners.

Service Users must meet the following referral criteria;

- · Be 18 years or over
- · Adults:
- · Be 18 year or over
- · BMI ≥40 without comorbidities
- · BMI of ≥35 in the presence of significant health conditions and comorbidities
- · BMI ≥27.5 for Asian (South Asian and Chinese), black African and African-Caribbean populations
- · Understanding of the commitment required to participate in Tier 3
- · Service Users understand the requirements and commitment needed to participate in Tier 3
- · Service Users must be registered with a Bassetlaw CCG GP.


