4. Is there a restriction on the number of lesions per consultation and if so how many?
5. What teledermatology image sharing platform(s) are you using?
6. What Teledermatology service model do you use (NHS provider led, 3rd party provider, Other)
7. What percentage of patients are managed in primary care without the need to be referred to secondary care?
8. What is the split for 1st dermatology appointments Face to Face, Non-Face to Face?
9. What is the time between sample taken (photo or biopsy) and the results reported?
10. Using the NHS e-Referral Service (e-RS). Can you please confirm the following: **\_ Unable to capture this Data as it does not sit on the Hospital PAS system and is not extractable**
  - a. volume of advice and guidance requests per GP/referrer
  - b. percentage of advice and guidance requests where further information is requested by provider
  - c. percentage of advice and guidance requests where 'referral only' is recommended
  - d. percentage of advice and guidance requests referred to same speciality within a defined window - 3 months or 6 months for example
  - e. percentage of advice and guidance requests which have been converted to a referral
