I am requesting the following information on local healthcare and support service provision for multiple myeloma patients as part of a wider project (funded by Myeloma UK). Please provide the following information:

As of 1 Jan 2024:

- Total population size served by Regional Board- 440,000
- Number of hospitals providing oncology services -1 Trust
- Total number of consultant haematologists employees; specialist haematology registrars employed; consultant haematologists specialising in multiple myeloma; haematology clinical nurse specialists employed and multiple myeloma clinical nurse specialists. —

1 speciality doctor
2 clinical nurse specialist

During 2023 (1 Jan – 31 Dec), please provide the:

- Total number of multiple myeloma (MM) cases diagnosed (Please state which code(s) were used) -see attached spreadsheet
- If known, how many people were diagnosed with smouldering multiple myeloma? see attached spreadsheet
- How many in-person haematology-based consultation/telephone haematology-based consultations/video haematology-based consultation took place for people diagnosed with MM?

I am writing to confirm that DBTH holds the information on the subject you have requested. However, I advise you that we will not be able to answer your request without exceeding the appropriate limit. This is because to [locate, retrieve, extract] information in scope of your request would involve extensive administrative work as there are not specific clinics for MM just general clinics, this would require reviewing each clinic and going on diagnosis then seeing which clinic type they were in which would not be feasible within the timeframe. Section 12 of the Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, We have estimated that it would take more than 18 hours to carry out a manual search to locate, retrieve, and extract all the information you have requested. In this situation the associated cost would therefore exceed the appropriate fee limit of £450 set out under Freedom of Information & Data Protection (Appropriate Limit and Fees) Regulations 2007.

The fee limit specified in regulations for NHS trusts represents the cost of one person spending $2\frac{1}{2}$ working days at a rate of £25 per hour determining whether the Trust holds the information sought and then locating, retrieving and extracting that information.
