This was a direct award based on PSR regulation. As MHS had a history of very good value for money.

- Undermine the Trust's ability to negotiate competitive rates in future procurement exercises, leading to increased costs.
- Impact the supplier's commercial position, allowing competitors to gain an unfair advantage by adjusting their pricing strategies accordingly.
- Distort future tendering processes, discouraging suppliers from offering their most competitive rates due to concerns over public disclosure.

#### **Public Interest Test**

As Section 43(2) is a qualified exemption, the Trust has conducted a public interest test to assess whether disclosure outweighs the commercial harm.

#### Factors in Favour of Disclosure:

- Promotes transparency and accountability in the use of public funds.
- Allows public scrutiny of NHS expenditure on MRI Insourcing services.

## Factors in Favour of Withholding:

- Protects the Trust's ability to secure cost-effective contracts in future negotiations.
- Prevents potential financial harm to the supplier, ensuring a fair and competitive procurement environment.
- Maintains the integrity of commercial relationships, ensuring continued supplier engagement with the NHS.

## Conclusion:

On balance, the public interest in maintaining commercial confidentiality outweighs the public interest in disclosure. Therefore, the cost per patient based on spend and patient numbers for MRI Insourcing MHS is withheld under Section 43(2) of the FOIA.
