I am specifically requesting information on the following data points:

- 1. The **number of patients** who received an ADHD assessment each year.
- 2. The **number of patients on the waiting list** to receive an ADHD Assessment at the end of each financial year.
- 3. The **average waiting time** for an ADHD assessment from the date of referral to the date of diagnosis.
