Freedom of Information Act Request

Under the Freedom of Information Act, I would like to request the following information:

After reviewing your request, we can confirm that the Trust does not hold the specific financial information you have requested. We do not routinely calculate or record the financial cost associated with Did Not Attend (DNA) or otherwise vacant outpatient clinic slots for individual clinical services. Therefore, we are unable to provide an average cost per DNA or vacant appointment slot.

Under section 1(1)(a) of the Freedom of Information Act 2000, a public authority is not obliged to provide information it does not hold. Furthermore, in accordance with section 17(1) of the Act, this response also acts as a formal refusal under section 1(1)(a). Should this information be required for operational purposes in the future, it may be possible to estimate associated costs based on clinic time, staffing, and other indirect factors, but such calculations would not reflect formally held or routinely maintained data.
