Freedom of Information Act Request

I would like to submit a Freedom of Information request under the Freedom of Information Act 2000. Please could you provide the following information:

I am writing to you under the Freedom of Information Act 2000 to request the following information from your trust. Please may you provide me with an answer to the following:

1. c Does your Trust provide a Tier 3 weight management service?

If yes:

a. How many patients did this service support in 2023/24?

I am unable to provide the exact number of patients who were supported by the service, as this information is not readily available in a reportable format. To obtain an accurate figure would require a manual review of individual patient records, which would exceed the appropriate cost limit set out under Section 12 of the Freedom of Information Act 2000. Under Section 12 of the Act, a public authority is not obliged to comply with a request if the cost of doing so would exceed the appropriate limit, which is currently set at £450 (equivalent to 18 hours

doing so would exceed the appropriate limit, which is currently set at £450 (equivalent to 18 hours of staff time at a statutory rate of £25 per hour). In this instance, it has been estimated that retrieving the information would exceed this limit.

However, we can advise that the Doncaster Tier 3 weight management service was commissioned and staffed to receive approximately 450 patient referrals per year.

 Bassetlaw service has 326 patients on waiting list
 Doncaster 1551 patients on waiting list
- c. What is the current average waiting time (in weeks) for this service?
 Bassetlaw service 1 year 1 week (53 weeks)
 Doncaster service 2 years (104 weeks)
- Does the Tier 3 service receive patients from other specialties within the Trust for weight management support (e.g., orthopaedics, cardiology) Yes
