The number of babies (under 1 year old, including stillbirths if applicable) who died in your care between 1 January 2010 and the present day (or the most recent available year).

Please note that where numbers are fewer than five (n<5), we have suppressed the data to protect patient confidentiality in accordance with Section 40(2) of the Freedom of Information Act 2000 and to follow best practice in statistical disclosure control

Where numbers are fewer than five, we have withheld the specific count in accordance with Section 40(2) of the Freedom of Information Act 2000. This is to avoid the risk of individuals being identified, directly or indirectly, when combined with other available information. This approach follows best practice in statistical disclosure control.

Please note that data relating to legal claims made in connection with the baby deaths referenced in your request is not held in a readily accessible format.

Information about legal claims, including whether they involved an admission of failure, is not stored in a centralised or searchable system. Retrieving this data would require a manual review of individual case files, complaints, legal records, and investigation reports across several departments. This would exceed the appropriate cost limit under Section 12 of the Freedom of Information Act 2000, which limits the time a public authority is required to spend on a request to 18 hours or £450 of staff time.

Additionally, we can confirm that for each year where claims were made in relation to baby deaths, the number of cases is fewer than five (n < 5). Due to the small numbers involved, even partial disclosure of claim details could risk identification of individuals when combined with other available information.

Therefore, in line with Section 40(2) of the Freedom of Information Act 2000 (protection of personal data), we are unable to disclose further detail regarding the claims, including any contributing factors or recorded ethnicity, where applicable.

If you are not satisfied with the handling of your request, you have the right to request an internal review. Requests for an internal review should be submitted within 40 working days from the date of this response, and should be addressed to d.wraith@nhs.net.
