

Does the patient have a wound which presents with 50% or less slough/ necrotic/devitalised tissue in the wound bed OR a wound that is more than 14 days old?

Patient requires Tier 2

Does the patient have a wound that is less than 14 days old with signs of positive healing (100%) granulation tissue) OR a have a Primary Closure Incision requiring removal of sutures/clips (ROS/ROC)?
