## **Exemption Applied: Section 43(2) – Commercial Interests**

The Trust is withholding the contract value under Section 43(2) of the Freedom of Information Act 2000, which states that information is exempt if its disclosure would, or would be likely to, prejudice the commercial interests of any person (including the public authority holding it).

Disclosure of the contract value could undermine the Trust's and the supplier's ability to negotiate future contracts on competitive terms. This could result in less favourable outcomes in future procurement exercises, ultimately reducing the effectiveness of public spending and harming the Trust's commercial position.

The Trust recognises that there is a public interest in openness and transparency regarding the use of public funds. However, on balance, the Trust considers that the potential harm to its commercial interests and its ability to secure best value in future procurements outweighs the public interest in disclosure in this case.
