

## **Freedom of Information Act Request**

Under the Freedom of Information Act, I would like to request the following information:

1. I would be grateful if you could send the Trust's most recent planning document(s) for the diagnosis and treatment of <u>Alzheimer's Disease</u> including implementation of lumbar punctures (CSF) and Blood-based Biomarker testing. Please include planning documents that cover the entire Trust and specific department plans, such as neurology, psychiatry, care of the elderly, pathology or memory clinic teams.

Doncaster and Bassetlaw Teaching Hospitals NHS Foundation Trust (DBTH) does not currently hold Trust-wide or departmental planning documents specifically for the diagnosis and treatment of Alzheimer's Disease, including the implementation of lumbar punctures for CSF or blood-based biomarker testing. The Trust is not commissioned to provide diagnostic dementia services. These services are delivered by external organisations, as outlined below.

These services are provided by Neurology teams from Sheffield Teaching Hospitals NHS Foundation Trust (STH) through outreach clinics, and by Memory Clinic teams operated by Rotherham Doncaster and South Humber NHS Foundation Trust (RDaSH).
