Under the Freedom of Information Act, I would like to request the following information:

I am writing to request the following information under the Freedom of Information Act 2000. Please provide data for the period Jan 2025 to June 2025 (last six months), broken down by calendar month where applicable The following request:

1. Emergency Department Bed delays for Adult Mental Health Patients (18-65yrs)

- The number of patients per month within the ED who have been deemed medically fit but awaiting a mental health bed for
- Greater than 24hrs
- Greater than 48hrs
- Greater than 72hrs

2. Acute Ward bed delays for Adult Mental Health patients (18-65yrs)

- The number of patients within Medical/ Surgical/ Obstetric Wards (including those who have been bedded within temporary areas such as daycare, SDEC etc) who have been deemed medically fit but are awaiting a mental health bed for

7. Capital Investment.

Do you have any plans to create a Mental Health Emergency Department (MHED) within your Trust (as outlined within the recent NHS 10 year plan Plan- extract below)

We will increase capacity for urgent mental health care by developing dedicated mental health emergency departments (MHEDs), ensuring patients get fast, same-day access to specialist support in an appropriate setting.

Over the course of the first half of this Plan, we will invest up to £120 million to bring the number of MHEDs to around 85, meaning there will be one co-located (or very close to) 50% of existing type 1 A&E units

While the Trust acknowledges the NHS Long Term Plan's ambition to increase capacity for urgent mental health care through the development of dedicated Mental Health Emergency Departments (MHEDs), at this stage we are unable to release any information regarding potential future plans or proposals within the Trust relating to the creation of an MHED.



In accordance with Section 22(1) of the Freedom of Information Act 2000, the Trust is withholding this information as it relates to material intended for future publication. The Trust, along with its partner organisations, is currently reviewing and developing service plans in collaboration with the Integrated Care System (ICS). Any confirmed proposals or developments will be published through official channels in due course.

This exemption is subject to a public interest test. The Trust recognises the public interest in transparency and accountability, particularly regarding future investment in mental health services. However, premature disclosure of plans that are still under discussion and subject to approval may cause confusion and misinterpretation and could undermine decision-making processes. On balance, the Trust believes that the public interest favours withholding the information until it is formally published.

For clarity, Doncaster and Bassetlaw Teaching Hospitals NHS Foundation Trust does not currently provide inpatient mental health services. These are commissioned and provided by Rotherham Doncaster and South Humber NHS Foundation Trust (RDaSH).
